#### **PROPERTY DESCRIPTION**

This property is a former religious facility in the heart of Central Lakeland, which has been well maintained and offers the opportunity for a turn key facility or perhaps a day care or school.

The vast 11,520 SF facility sits on almost 5 acres and offers multiple offices, classrooms, as well as two large multi-stall bathrooms. There is a full kitchen and fellowship area, and also a large traditional sanctuary with an attached gym, which could easily be transformed into another flex area.

The building has two entrances, with two separate hallways, which lead to the classrooms and offices, with the sanctuary and flex space in the middle of the structure. The floor plan is available. Topping off the property is vacant acreage behind the church, which holds several possibilities including expansion or residential development. There are also 118 parking spaces.


- Church/special purpose property 11,520 square feet on 4.85 Acres.
