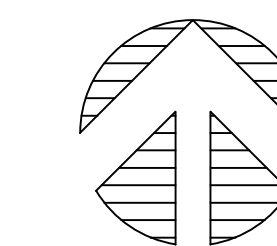


# BOUNDARY SURVEY

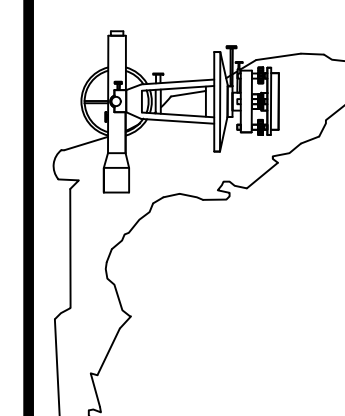
