In the identified area, the current year population is 178,988. In 2010, the Census count in the area was 178,897. The rate of change since 2010 was 0.01% annually. The five-year projection for the population in the area is 177,764 representing a change of -0.14% annually from 2019 to 2024. Currently, the population is 48.2% male and 51.8% female.

Median Age

The median age in this area is 37.3, compared to U.S. median age of 38.5.

Currently, 52.8% of the 76,317 housing units in the area are owner occupied; 31.7%, renter occupied; and 15.5% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 76,690 housing units in the area - 57.4% owner occupied, 28.3% renter occupied, and 14.3% vacant. The annual rate of change in housing units since 2010 is -0.22%. Median home value in the area is \$233,932, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 1.95% annually to \$257,671.
