Charlie Orden, almost a native of Florida, moved to Orlando thirty-four years ago while serving as president of the family chain of retail clothing stores. A few years later, due to a desire to sell real estate, he went to work for a home building company and has been a leader in the industry. Charlie worked for ABD Development Co. for 8 years as its Director of Sales and Marketing and lead sales executive. Charlie played a major role in the tremendous growth and success of ABD. He was responsible for sales and marketing of five communities, including the creative development of ABD's flagship project "VIZCAYA", a \$300,000,000 residential community of condominiums and single-family homes. In addition, he also sold and closed over 58 million dollars of residential and commercial real estate for ABD during his last 2 years, which made him Central Florida's Top Producer 2 years in a row.

In 2002, Charlie Orden founded RE/MAX Town Centre located in Orlando, Florida. His organization grew from 4 agents to over 100 top producing Realtors. The company is made up of Residential, Commercial, Leasing & Property Management, International Sales, Business Brokerage, Association Management and Builder Services which market developers' inventory domestically as well as internationally. Currently the organization represents several builders, developers, condominium associations as well as the management of commercial office buildings, shopping centers and residential properties for their owners. Charlie has served on the executive staff of several homebuilders and developers as Director of Residential Sales & Marketing in which he was responsible for achieving outstanding sales results.

After 20 years of owning and managing RE/MAX Town Centre, Charlie Orden sold the RE/MAX Town Centre brokerage (May 2021) to focus all of his efforts on selling commercial and residential properties, leasing & management of commercial retail & office buildings as well as managing condominium & homeowner associations.
