This parcel has a IND & BPC 2 zoning classification, Unincorporated Polk County, which provide many possible uses.


There are two wells on site and septic. There is also power to the property, and it is fully fenced with a gate.

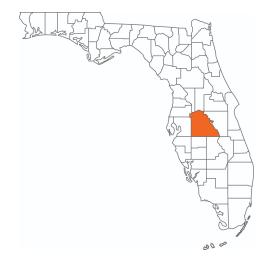


