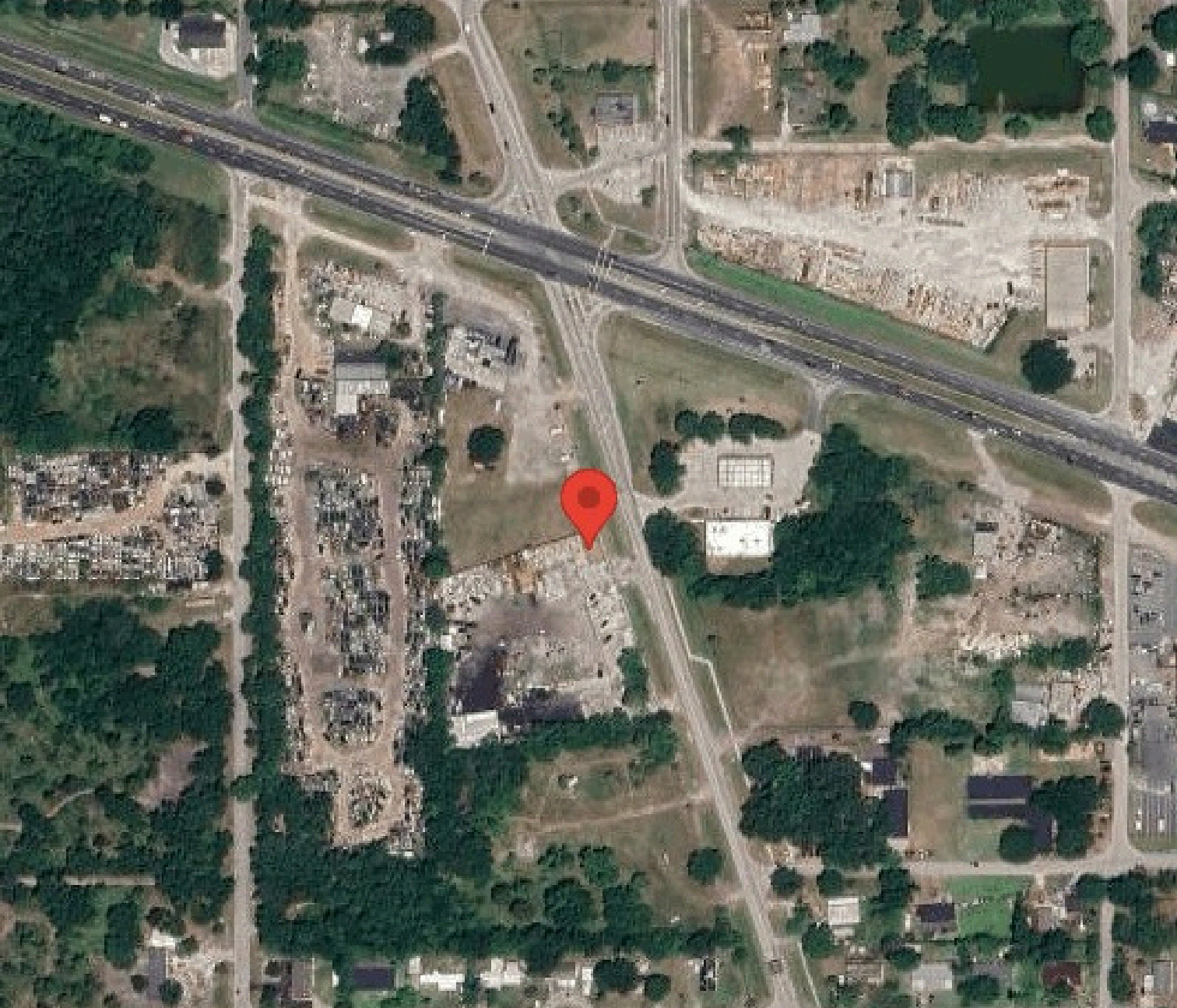
LOCATION MAPS

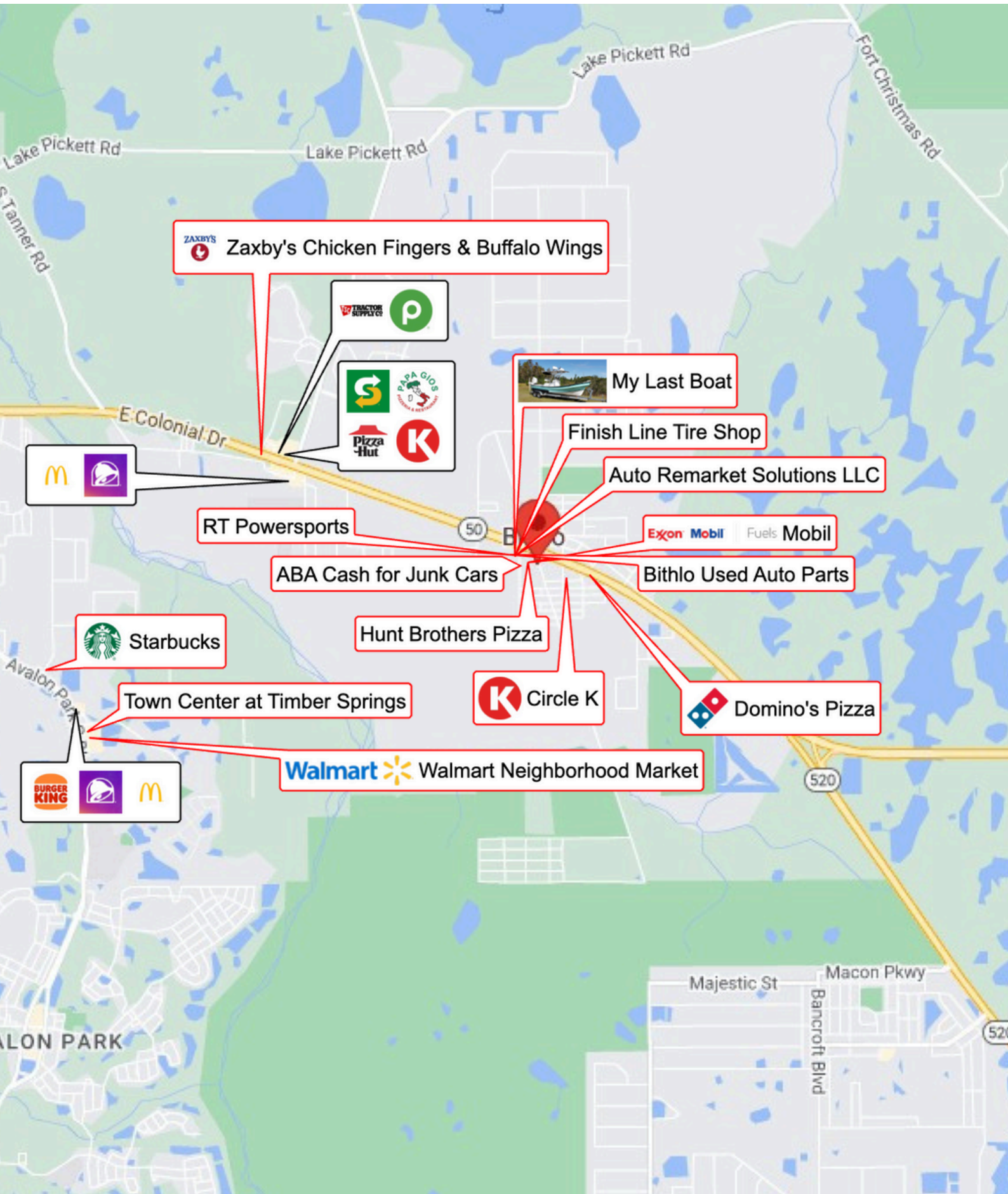
