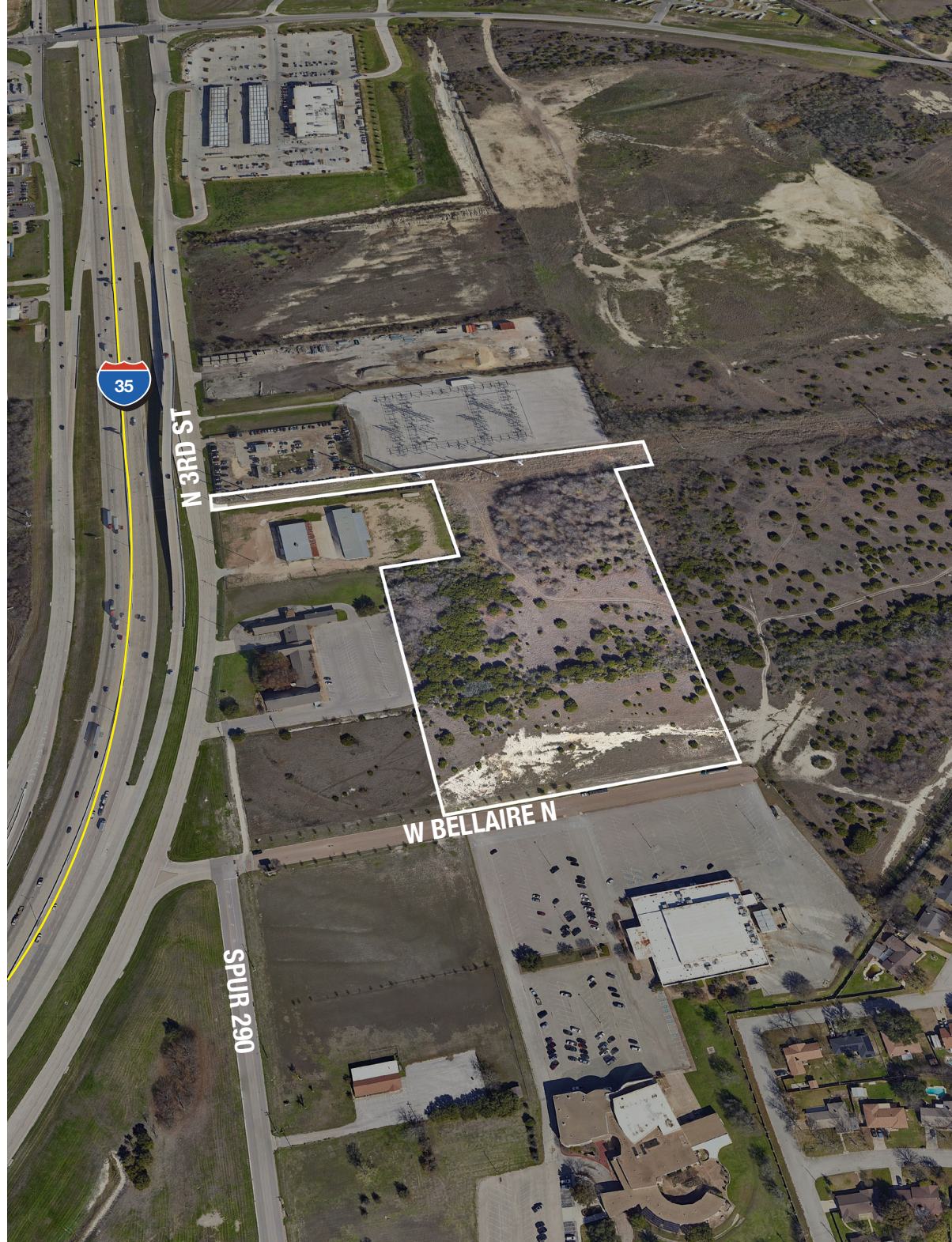

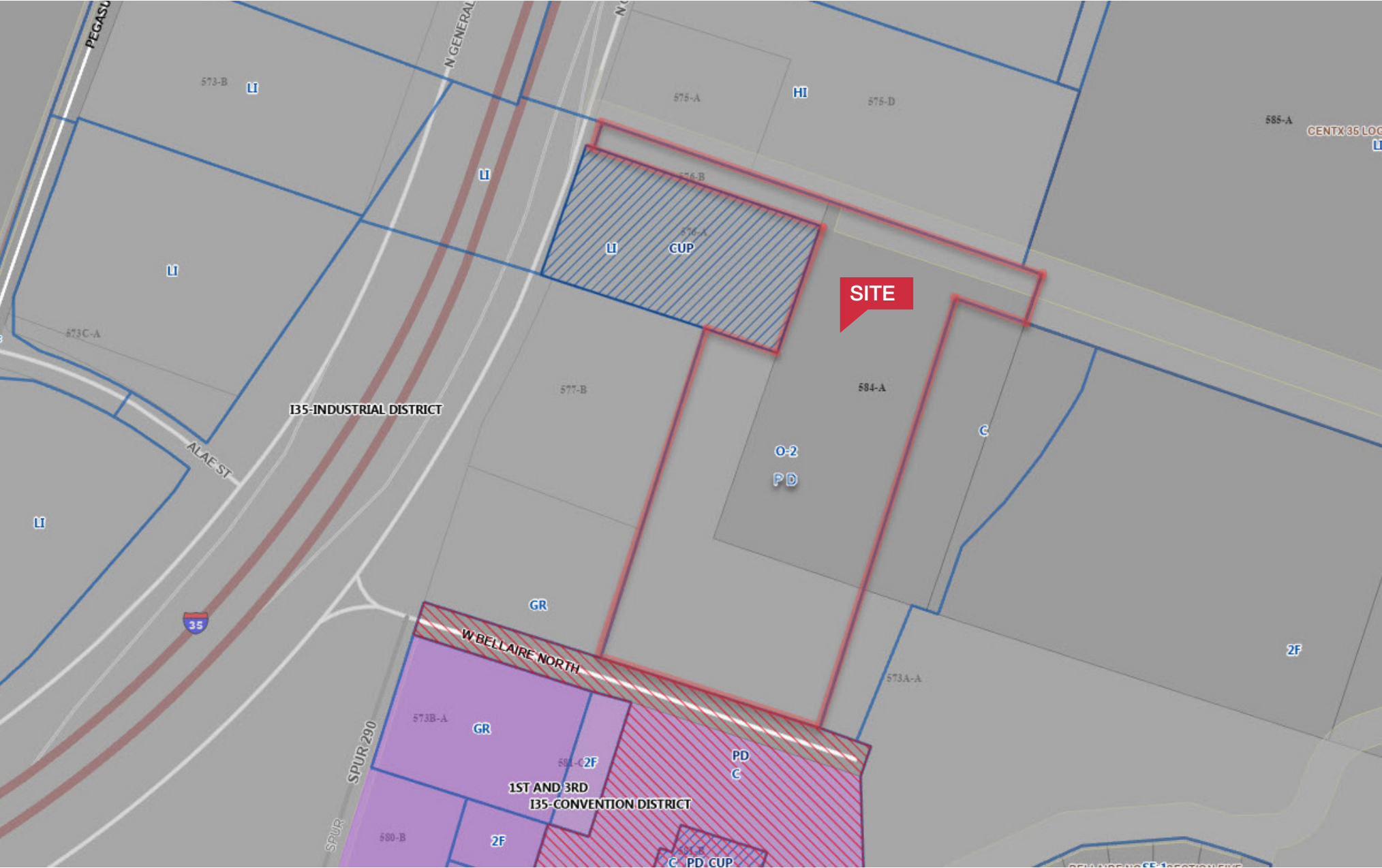

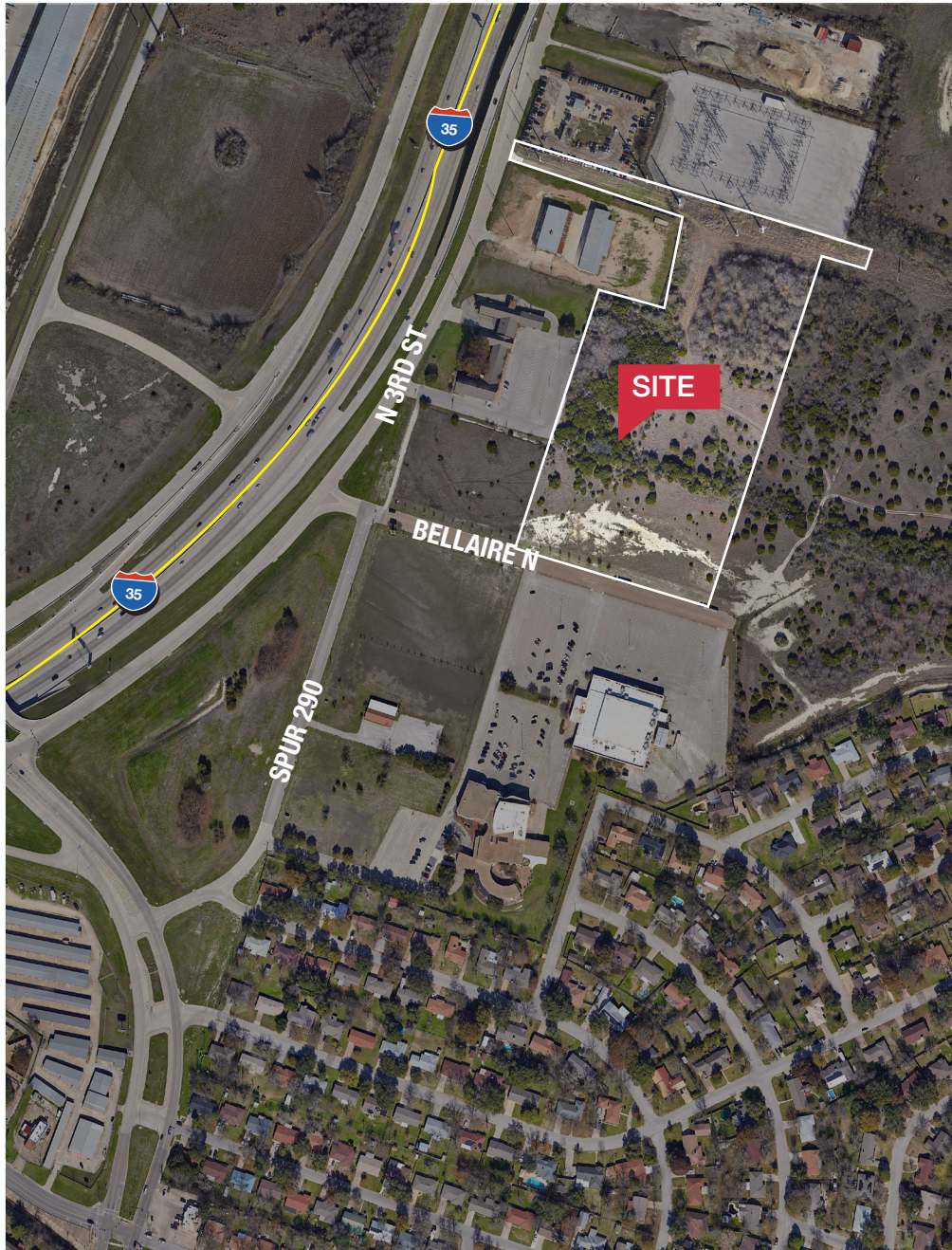


Zoning Map

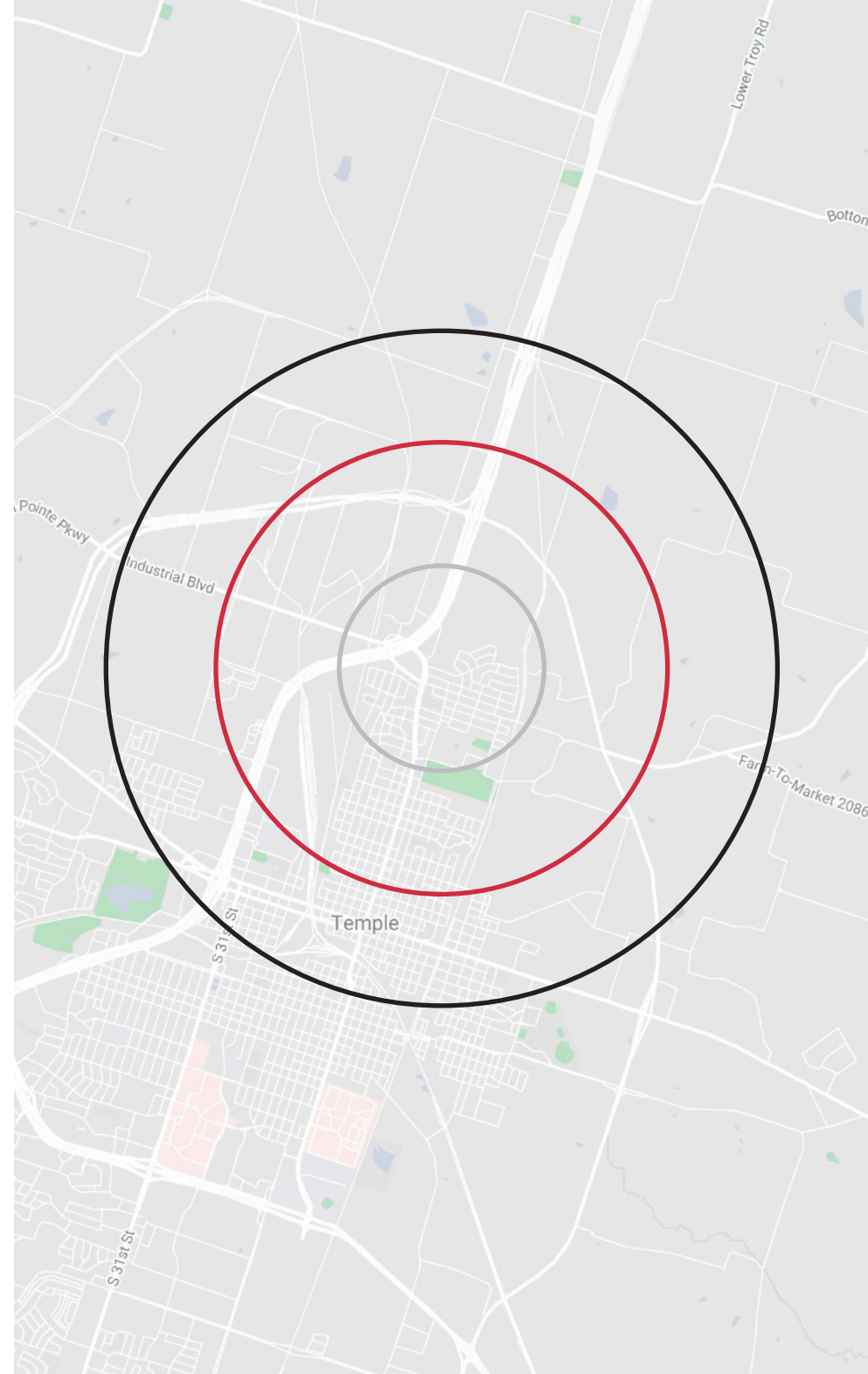
