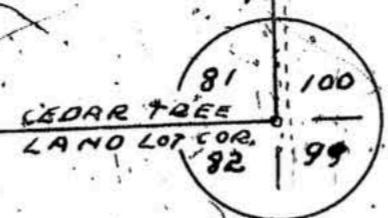




LANDS OF JAMES G. PATTERSON

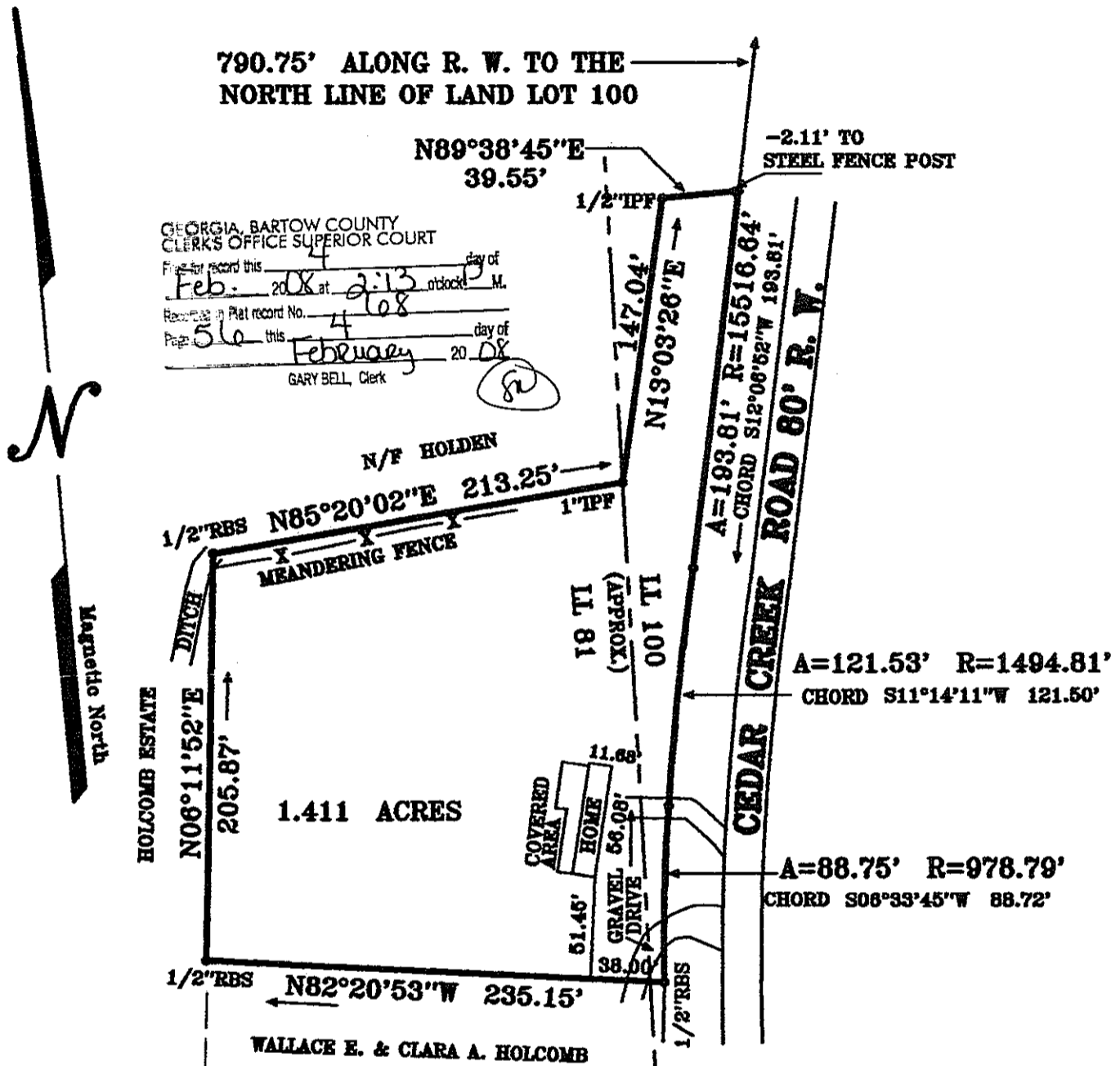

All that tract or parcel of land lying and being in the 5th District and 3rd Section of Bartow County, Georgia, being a part of Land Lot 81, and more particularly described as follows:

BEGINNING at an iron stake which is located on the West side of Folsom Road and the Southeast corner post of Land Lot Number 81, this being the POINT OF BEGINNING; Thence running North along said Land Lot Number 81 and the West side of Folsom Road a distance of 210 feet to an iron stake; thence running due West a distance of 420 feet to an iron stake; thence running due South a Distance of 210 feet to an iron stake and the intersection of the southern Boundary line of Land Lot Number 81; thence running due East along said Land Lot 81 Boundary line a distance of 420 feet to an iron stake and the Southeast corner post of Land Lot Number 81, this also being the Point of Beginning.
