In the identified area, the current year population is 147,673. In 2020, the Census count in the area was 135,383. The rate of change since 2020 was 2.71% annually. The five-year projection for the population in the area is 154,834 representing a change of 0.95% annually from 2023 to 2028. Currently, the population is 49.1% male and 50.9% female.
