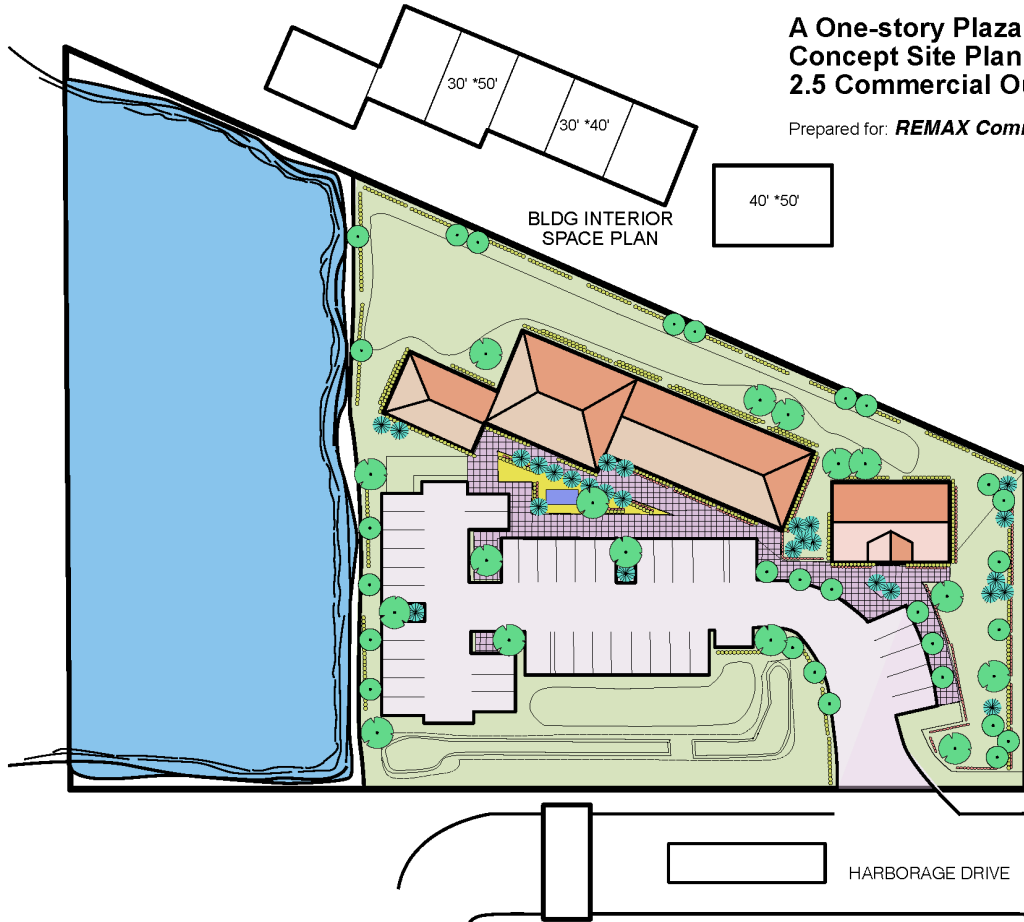

PERMITTED USES

- a.) Bakeries - Primarily retail, limited preparation;
- b.) Day care center and other preschool facilities;
- c.) Hardware store;
- d.) On-site signs, provided such signs comply with all applicable regulations and ordinances;
- e.) Personal services - including barber and beauty shops, health spas, laundry and dry-cleaning pickup establishments, self service laundromats and the like;
- f.) Pharmacy;
- g.) Place of worship;
- h.) Repair services - including small electric appliance, radio and television, tailor shop, similar specialized repair services;
- i.) Specialty shop - including bookstore, butcher, florist, gift and souvenir shop, newsstand, music shop, optical shop, stationary store, shoe shop, art, hobby and craft shop, tobacco shop and the like. 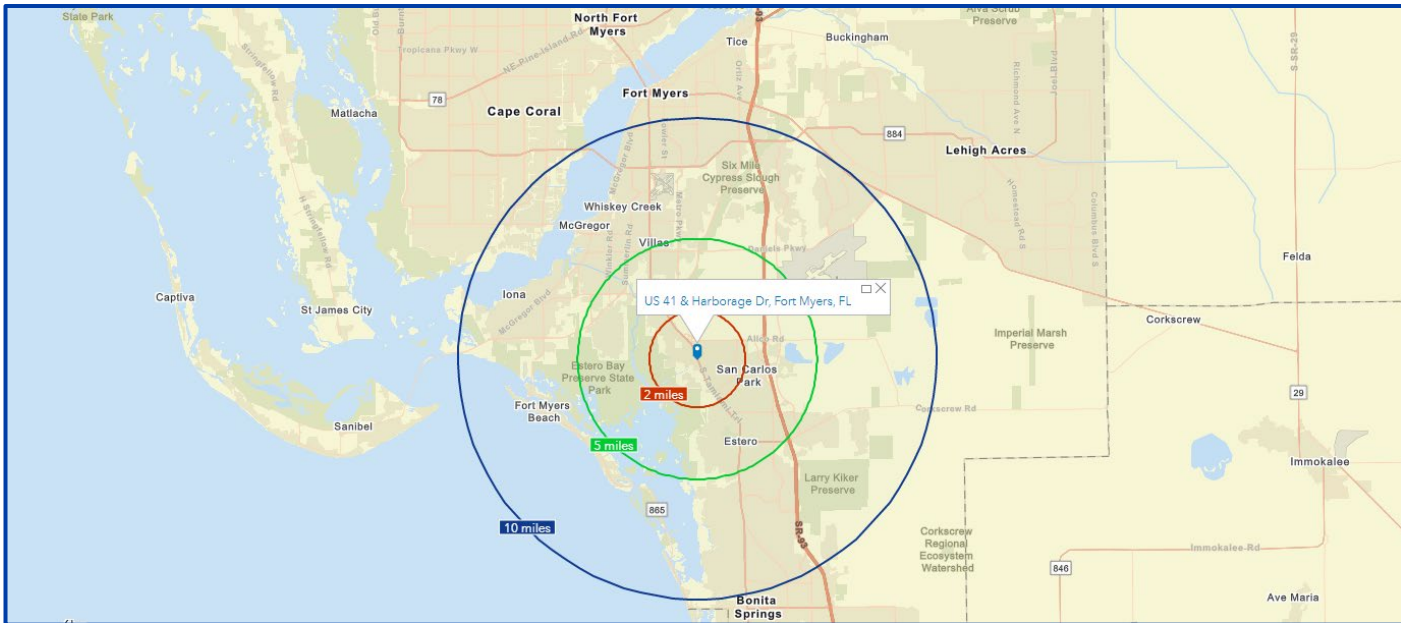
