



LOCATION NOTES

The property is located off US 1, adjacent to vacant parcels to the west owned by U Haul and south of the Savanna Ridge Elementary School. The Savannas Preserve State Park is nearby on the Indian River; golf is available at nearby Savanna Club and 4.6 miles north at Gator Trace.

US 1 hosts a range of commercial uses: residential development including multifamily housing is prominent off US 1. There is a Publix grocery store 1.2 miles away to the south at Prima Vista Blvd. and Walmart Supercenter six (6) miles south on US 1.

SIGNIFICANT FEATURES

Port St Lucie has experienced rapid growth in recent years and is one of the fastest growing cities in Florida and indeed the US. Walton & One - a transfomational development is less than 5 miles from the site
