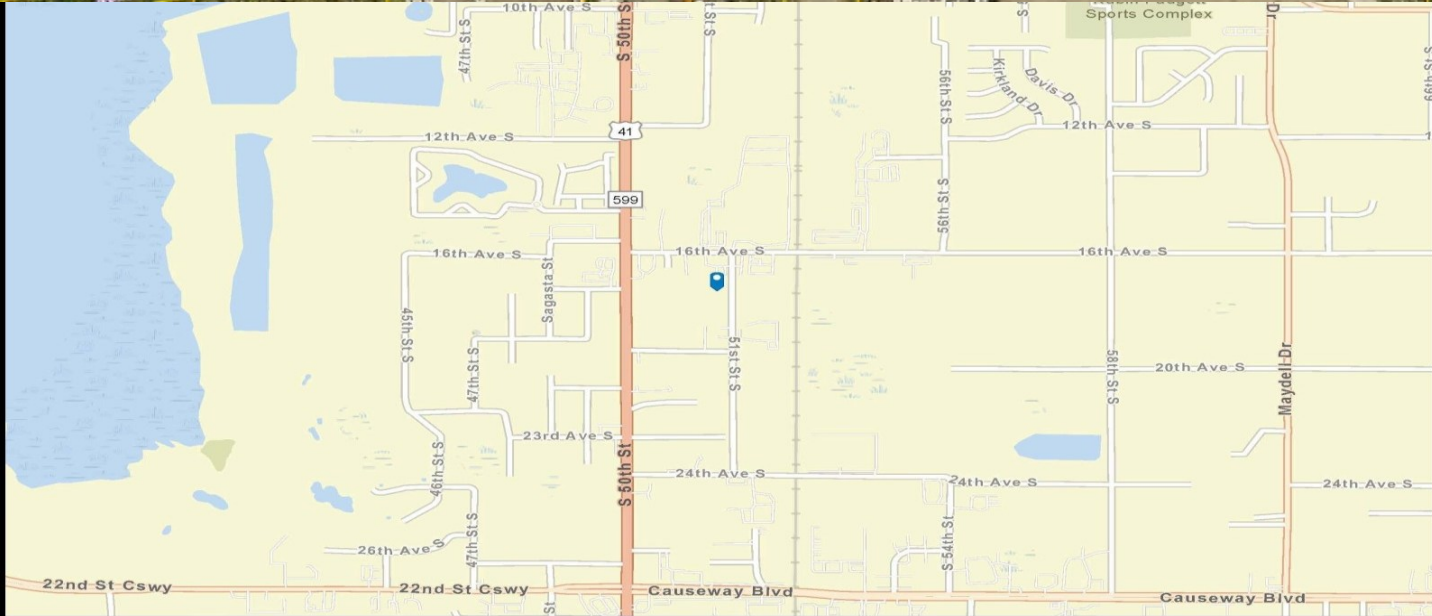

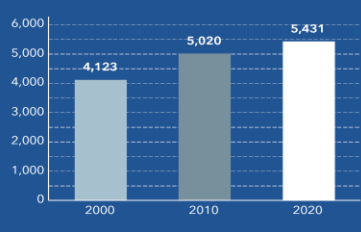

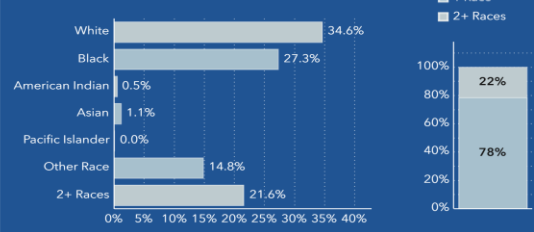
### 2010-2020 ANNUAL GROWTH RATE



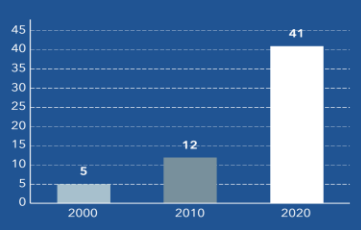
### HOUSEHOLD POPULATION



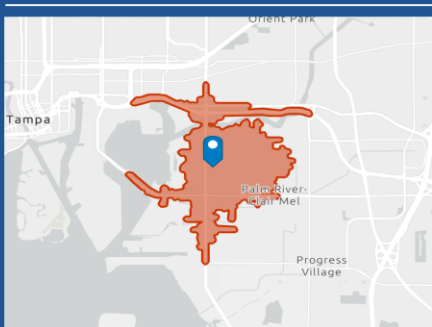
### TOTAL POPULATION BY RACE
