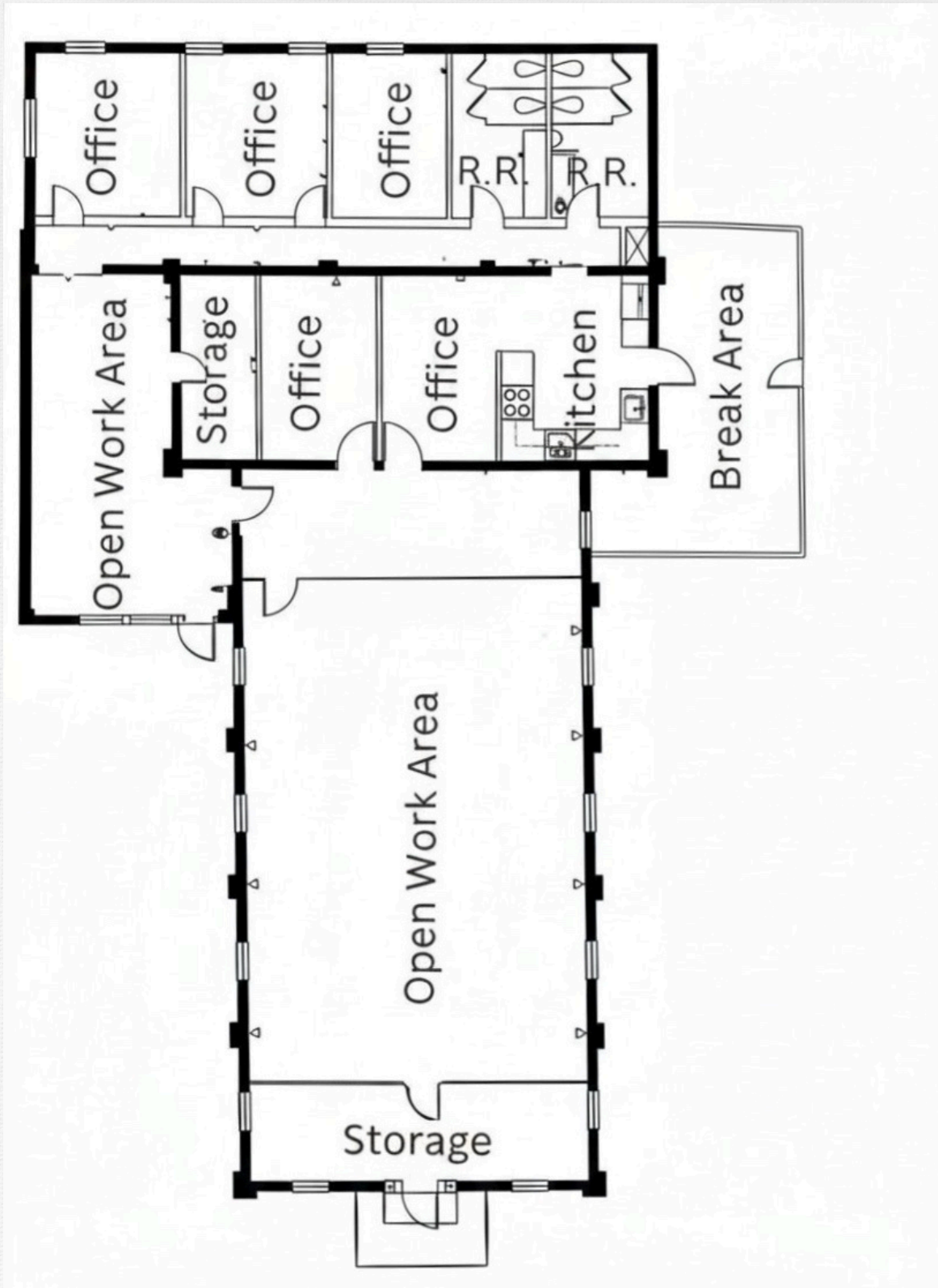

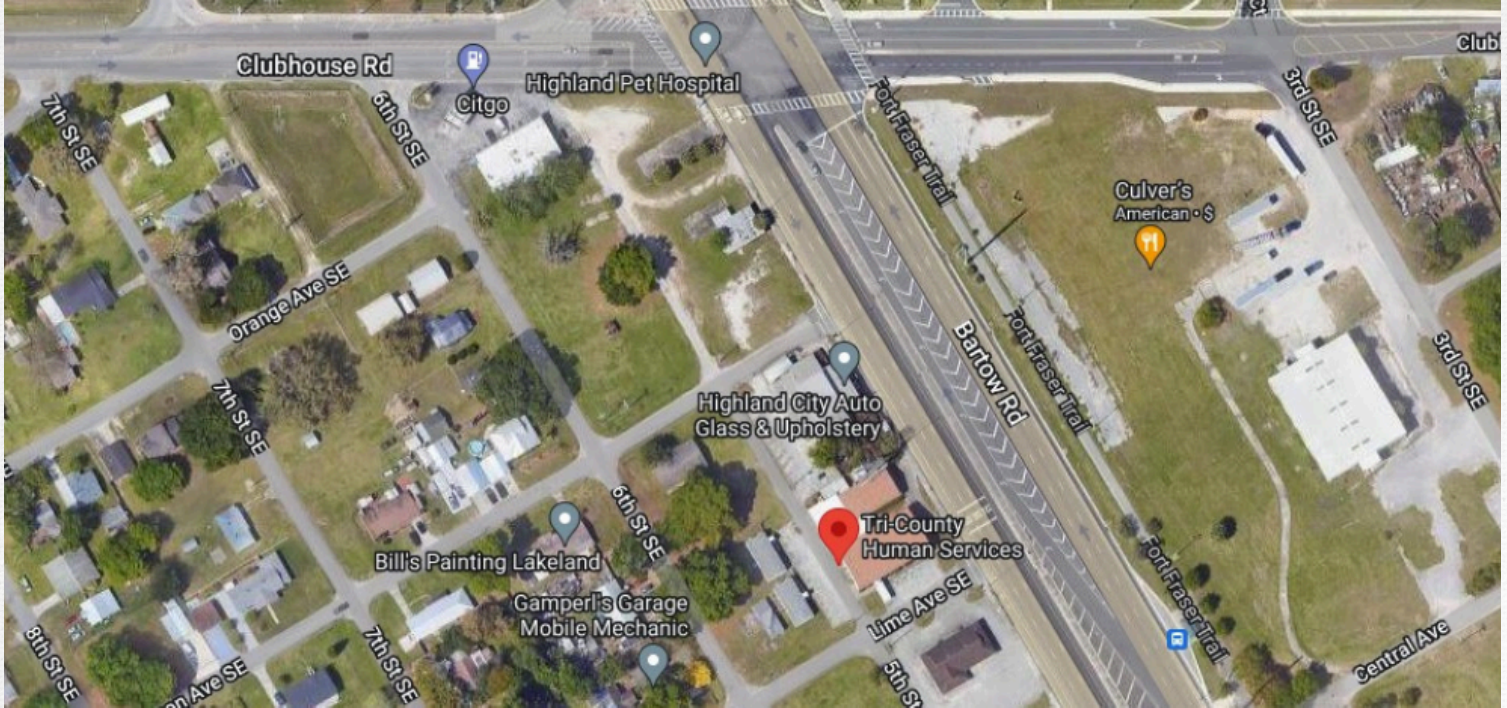
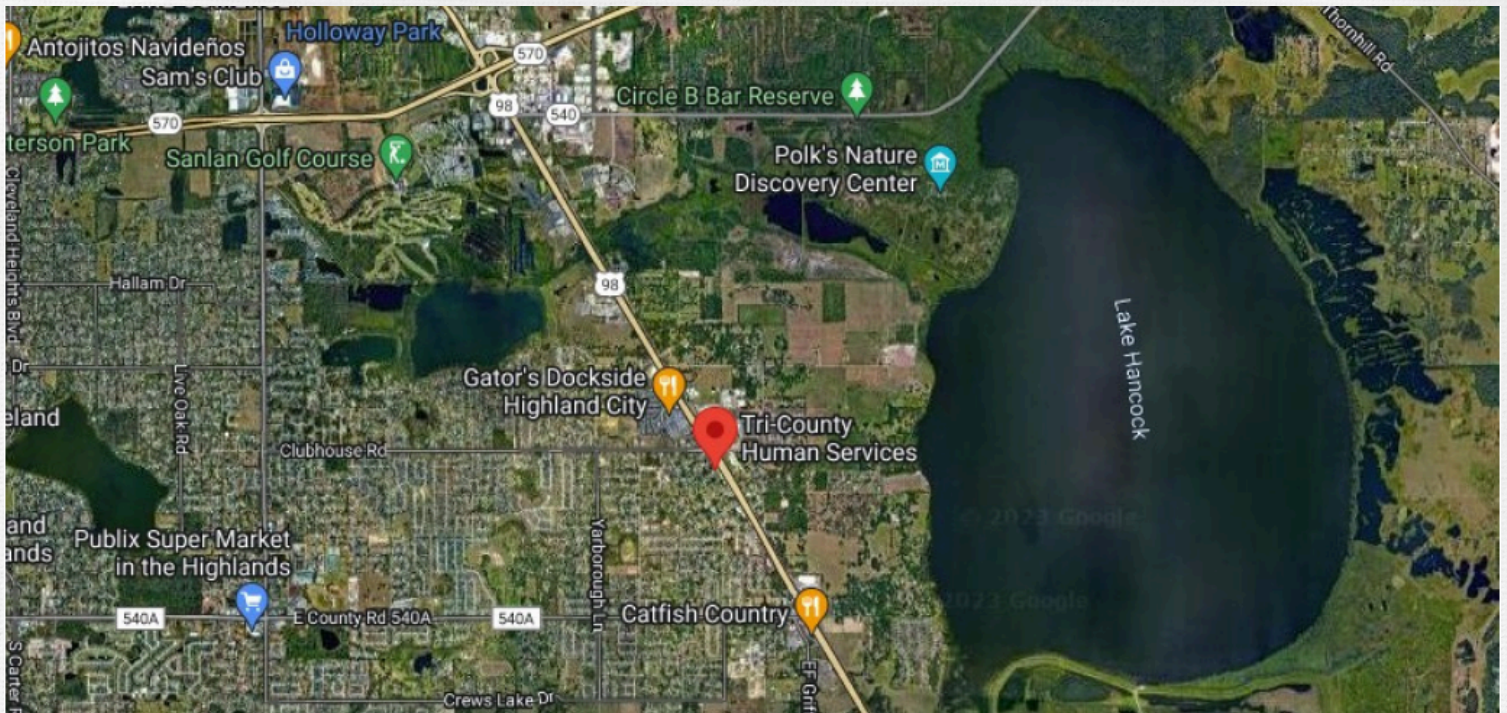
Floor Plan
