Positioned along Livingston Avenue with direct access and significant privacy, the property combines residential functionality, scenic natural surroundings, and future adaptive-use potential in one of Hillsborough County's growing submarkets.

The property currently features a well-maintained single-family residence situated toward the front of the site, while the rear portion opens into expansive green space overlooking a private lake with additional land extending beyond the water feature. There is also a separate 4 car tandem garage, and a chicken coop facility. This unique combination of usable acreage, waterfront scenery, and accessibility creates a compelling opportunity for investors, specialty operators, owner-users, or visionary developers seeking a distinctive asset beyond a traditional residential offering. There is the potential for a developer to divide the lot into 3-4 separate parcels.
