It is part of the team's dedicated training and player facilities, providing the Wild with a private space where players can prepare for practices, change, meet with teammates and coaches, and get ready for on-ice activities.

The locker room is designed as a functional part of the Wild's professional training environment. Its location directly within the Treasure Island Center allows players to move efficiently between their private team areas and the rink on Level 5. Together with the team's other lower-level facilities, the locker room helps make Treasure Island Center a year-round home for the Wild's practices and hockey operations.

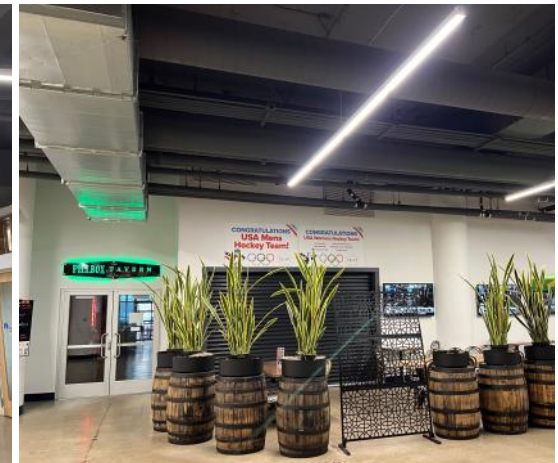
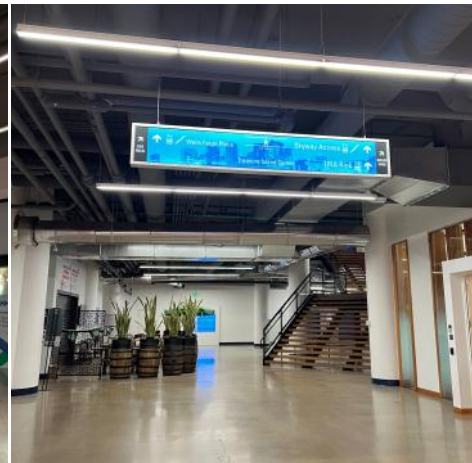
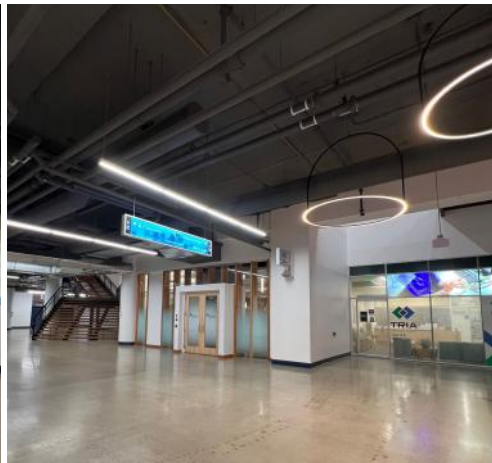
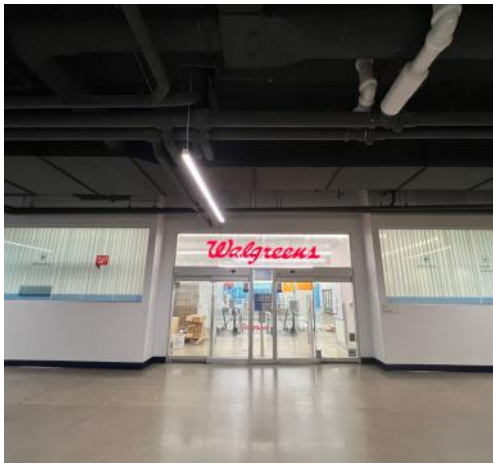




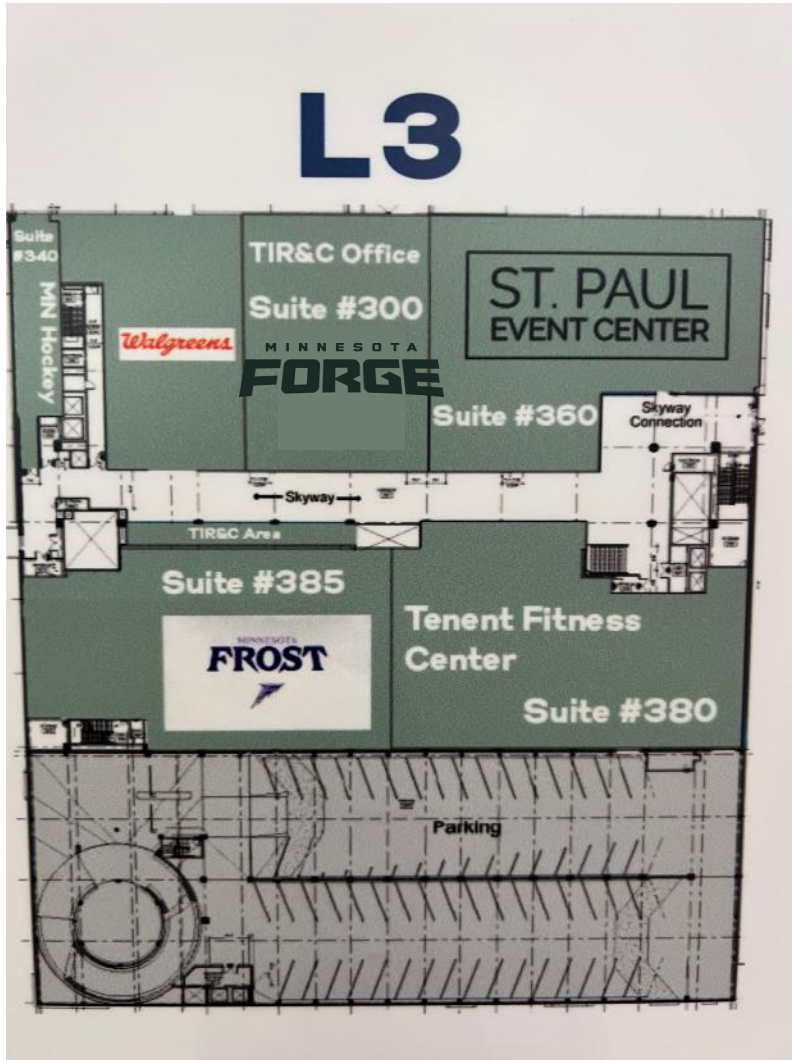

The St. Paul Public Housing Agency (SPPHA) is the site for the public housing authority serving Saint Paul, Minnesota, located at 555 Wabasha Street North. Its stated mission is to help families and individuals with low incomes achieve greater stability and self-reliance by providing safe, affordable, quality housing and links to community services. The agency runs several major federal housing programs, most notably traditional Public Housing (including hi-rises and scattered-site homes and duplexes), the Section 8 Housing Choice Voucher program, and RAD (Rental Assistance Demonstration), which covers its multifamily housing waiting list and related conversions.



Level 5 of Treasure Island Center is home to TRIA Rink, the Minnesota Wild's practice facility in downtown St. Paul. The rink provides the team with a dedicated space for daily practices, drills, skating work, and preparation during the NHL season. The facility features a full-size ice surface and is designed to support both professional hockey and a variety of community skating activities.

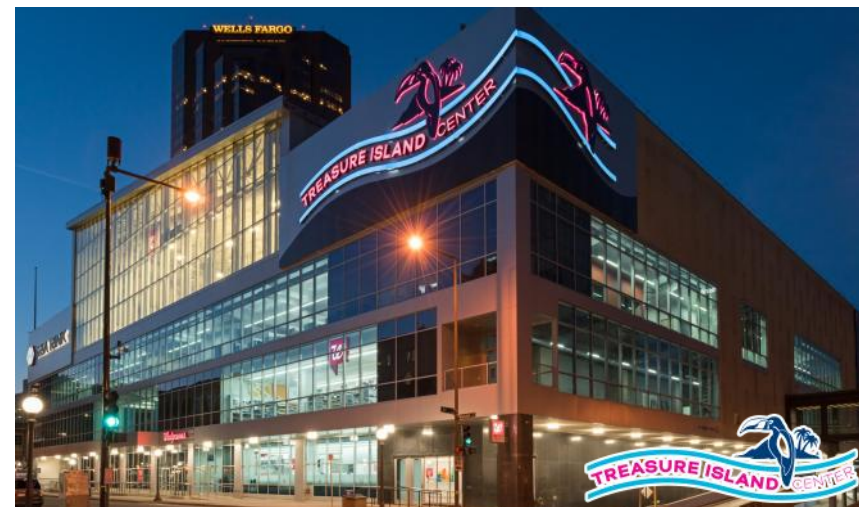
For the Minnesota Wild, the Level 5 rink is an important part of their daily hockey operations. Players and coaches use the ice for practices and on-ice preparation, while the surrounding facility provides access to the team's training and support areas. With the rink located inside the historic Treasure Island Center, Level 5 combines a modern professional hockey environment with a central downtown location.

Walgreens is located within the Treasure Island Center, a vibrant mixed-use redevelopment in the heart of downtown St. Paul, Minnesota. Originally constructed in 1962 as a department store, the building sat vacant for several years before being transformed into a modern destination that now combines retail, office, medical, and recreational space. At the core of the building is the TRIA Rink, a rooftop, NHL-regulation ice rink that serves as the official practice facility for the Minnesota Wild and also hosts community events, college hockey games, and figure skating.

The center spans multiple floors and houses tenants including Walgreen's, Pillbox Tavern, TRIA Orthopedic, Saint Paul Event Center, Equity on Ice Centers, Saint Paul Port Authority, Treasure Island Resort & Casino, and Minnesota Housing. It is connected to the downtown skyway system, making it easily accessible for both pedestrians and eventgoers. The redevelopment was made possible through a partnership with the Saint Paul Port Authority and the Prairie Island Indian Community, whose Treasure Island Resort & Casino holds the naming rights. Treasure Island Center has helped breathe new life into a key block of the city, anchoring economic activity and bringing year-round energy to the area.

In addition to its retail and recreational offerings, Treasure Island Center provides valuable office space for both public and private organizations, contributing to the vibrancy of downtown St. Paul's business environment. Tenants benefit from the building's central location, parking options, and direct access to the city's skyway system. The renovation preserved parts of the original structure while incorporating modern upgrades, creating a unique blend of historic character and contemporary design.



Walgreens is located next to the St. Paul Event Center and located blocks from Grand Casino Arena, The Minnesota State Capitol, The Science Museum of Minnesota, Minnesota History Center, River Centre, Ordway Theatre, Palace Theatre, EcoLab Headquarters, The Depot, Unit Hospital, and much more.

St. Paul, Minnesota, Minnesota's state capital, is a dynamic blend of historic charm and modern vitality. As one half of the Twin Cities, alongside Minneapolis, St. Paul is known for its stately architecture, riverfront setting along the Mississippi, and rich cultural heritage. The city is home to landmarks such as the Minnesota State Capitol, Cathedral of Saint Paul, and the James J. Hill House—each offering a glimpse into the area's past. Neighborhoods like Summit Hill, Lowertown, and Highland Park showcase a mix of Victorian homes, artist lofts, and bustling commercial districts.

St. Paul also thrives as a hub for arts, education, and government. Institutions like the Science Museum of Minnesota and the Minnesota History Center draw residents and visitors alike. The Ordway Center for the Performing Arts and the Minnesota Museum of American Art further highlight the city's dedication to creativity and culture. As the seat of state government, St. Paul supports a wide range of civic events and public services, all while maintaining a close-knit community feel.

Throughout the year, St. Paul plays host to numerous festivals and events, most notably the Saint Paul Winter Carnival, one of the oldest and largest winter festivals in the U.S. Outdoor enthusiasts enjoy nearby parks, trails, and the riverfront, while sports fans rally behind the St. Paul Saints baseball team or head to the Grand Casino Arena to catch a Minnesota Wild hockey game. With its strong sense of identity, diverse population, and balance of tradition and progress, St. Paul offers both residents and visitors a uniquely Minnesotan experience.

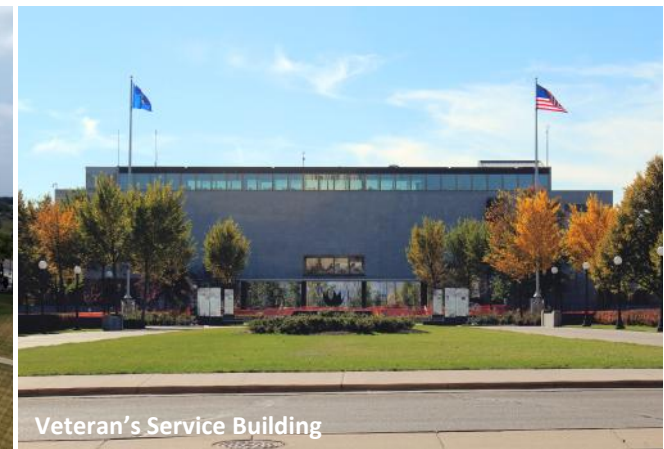

The Minnesota State Capitol, located just north of downtown St. Paul, is a landmark of both architectural beauty and political importance. Designed by Cass Gilbert and completed in 1905, the building showcases Beaux-Arts and Renaissance Revival styles, constructed from white Georgia marble and St. Cloud granite. Its most striking feature is the massive dome—one of the largest self-supporting marble domes in the world—topped with a golden chariot sculpture called the Quadriga. A major restoration project completed in 2017 revitalized the Capitol's original art, stonework, and public areas, preserving it for future generations.

Surrounding the Capitol is a prominent civic district filled with state government buildings that form a central government campus in St. Paul. The Capitol Mall stretches out in front of the building, landscaped with memorials dedicated to veterans, workers, and other key figures in Minnesota history. Nearby are the Minnesota Judicial Center, the Veterans Service Building, the Transportation Building, and the Administration Building, among others. These structures house a range of state departments and serve as the administrative backbone of Minnesota's government operations.

Inside the Capitol, the chambers of the House of Representatives and Senate are open to the public, along with the offices of the Governor and other constitutional officers. Visitors can also view restored murals, decorative ceilings, and historic furnishings, with the lower level featuring the Rathskeller café, a uniquely painted space with German-style décor. The building is open for tours throughout the year, offering Minnesotans and tourists a glimpse into the state's legislative process and rich architectural heritage. The Capitol and its surrounding buildings remain the heart of state government and a focal point for civic engagement in Minnesota.

The Grand Casino Arena, formerly “Xcel Energy Center,” is a premier multi-purpose arena located in downtown St. Paul, Minnesota. Opened in 2000, it serves as the home venue for the NHL’s Minnesota Wild and the Professional Women’s Hockey League’s Minnesota Frost. The arena seats nearly 18,000 fans for hockey games and can accommodate over 20,000 for concerts and other events. Each year, the Grand Casino Arena hosts more than 150 events, including major concerts, sporting competitions, family shows, and special community gatherings, making it one of the busiest venues in the region.

The Minnesota Wild play 41 home games at the Grand Casino Arena each regular season, drawing passionate crowds that contribute significantly to the arena’s energetic atmosphere. The team’s schedule typically includes a mix of weekday and weekend games, with some months featuring extended homestands where multiple games occur within a few weeks. These games are major events for the city, attracting fans from across Minnesota and neighboring states to downtown St. Paul.

Beyond hockey, the Grand Casino Arena is a versatile venue that hosts a wide variety of high-profile events. It has been the site of NCAA Frozen Four hockey tournaments, major political conventions, and nationally touring concerts by top artists. Additionally, the arena frequently welcomes family-friendly shows, comedy acts, and other entertainment events throughout the year. Its modern facilities and central location ensure it remains a key hub for sports and entertainment in the Twin Cities area.

St. Paul is home to a vibrant performing arts scene, anchored by several historic and modern theaters that contribute to the city's cultural identity. The **Ordway Center for the Performing Arts**, located across from Rice Park, is one of the city's premier venues. Opened in 1985, the Ordway hosts a wide variety of performances including Broadway musicals, orchestral concerts, dance, and opera. It features two main performance spaces: the Music Theater with nearly 1,900 seats and the more intimate Concert Hall, added in 2015. The Ordway is also home to resident arts organizations such as the Minnesota Opera, the Saint Paul Chamber Orchestra, and the Schubert Club, making it a cornerstone for classical and contemporary arts in Minnesota.

The **Palace Theatre**, a restored early-20th-century venue on West Seventh Place, adds a different kind of energy to downtown St. Paul. Originally opened in 1916 as a vaudeville house, the Palace was later used as a movie theater before closing in 1977. After sitting dormant for nearly 40 years, the city restored and reopened the theater in 2017 as a live music venue with a capacity of roughly 2,500. With its raw, industrial aesthetic preserved from the original structure, the Palace now draws large crowds for concerts and live events, and is co-operated by First Avenue and JAM Productions. Its reintroduction has played a major role in the revitalization of the city's nightlife.

In addition to the Ordway and Palace, St. Paul features several other important theaters. **Park Square Theatre**, located in the historic Hamm Building, is known for its intimate productions of contemporary and classic plays, often focusing on social issues and diverse voices. Nearby, **History Theatre** stages original works that reflect Minnesota's history and cultural heritage. The **Fitzgerald Theater**, the oldest active theater in the city, is well known for hosting "A Prairie Home Companion" and continues to offer concerts, literary readings, and comedy performances. Smaller venues like **Gremlin Theatre** and **Black Box Theatre** support independent productions and emerging artists, helping ensure that St. Paul remains a dynamic hub for storytelling and stagecraft.

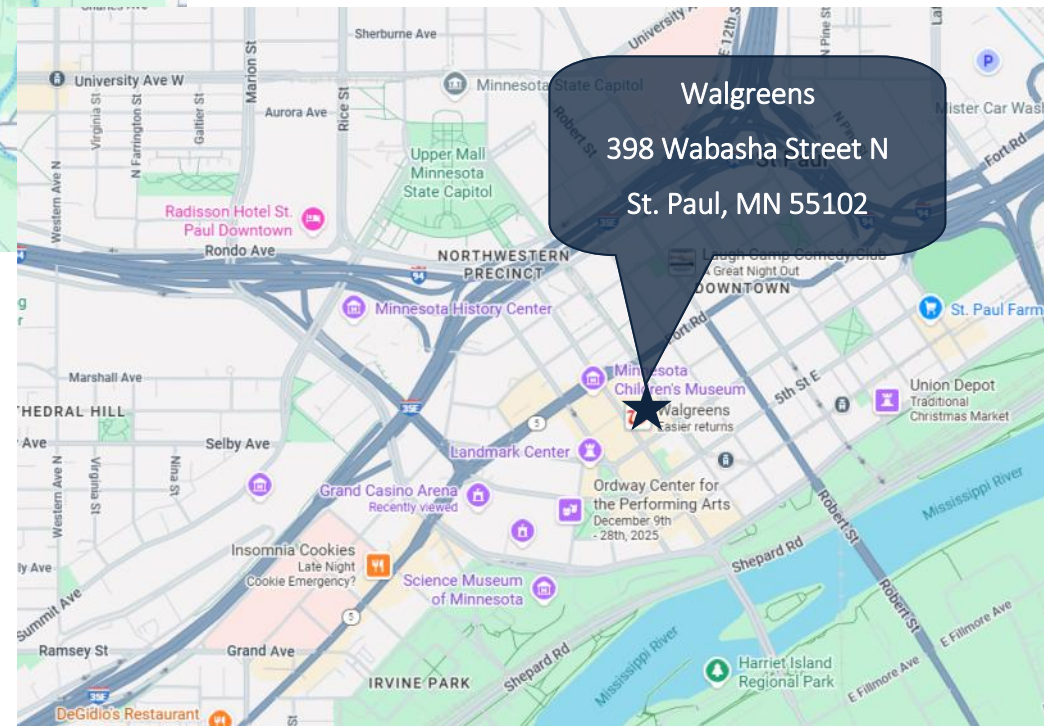
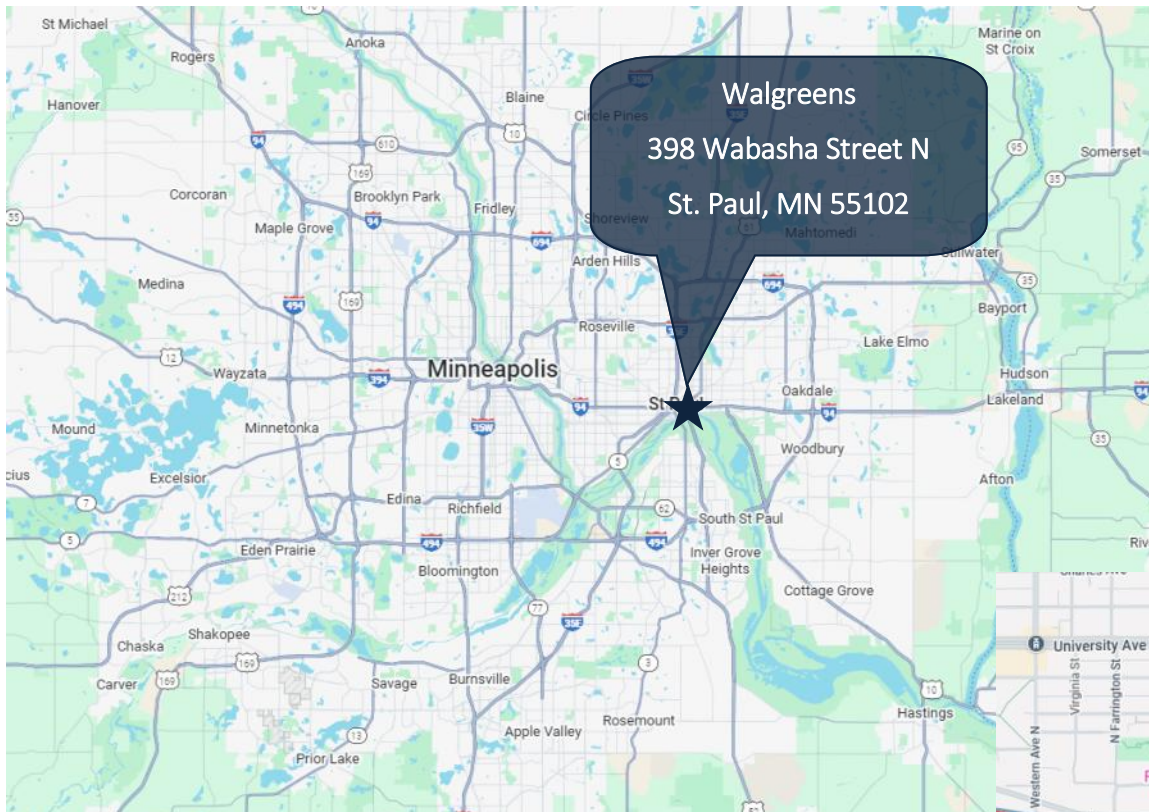
