The report covered the recent liquidation of sports cars, office furnishings, collectibles seized by the Federal Trade Commission from a credit card scam operation.

Recently, the firm liquidated the assets of RKT Constructors in Kissimmee, including heavy trucks, trailers, track hoes, and other construction equipment. The client's presale estimate of \$600,000 was exceeded by more than 50% for a total of over \$900,000.

Another major accomplishment was the recent \$9,000,000 sale of a 141 room hotel in Kissimmee, FL.

Randy regularly attends conferences and seminars to keep abreast of the auction and real estate marketing industry and improve his professional skills. He holds CCIM designation in commercial real estate and the CAI designation in auctioneering.
