





A drip irrigation system is in place. Wells for irrigation are located throughout the property. Mobile pumps (via truck or trailer) supply water to the irrigation system.








Population by Age




Population by Age




Redland Homestead Property Ring: 10 mile radius




Trends 2013-2018




Population by Age
