Currently, 66.6% of the 18,012 housing units in the area are owner occupied; 25.6%, renter occupied; and 7.8% are vacant. Currently, in the U.S., 56.0% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.6% are vacant. In 2010, there were 17,956 housing units in the area - 68.7% owner occupied, 24.4% renter occupied, and 6.9% vacant. The annual rate of change in housing units since 2010 is 0.14%. Median home value in the area is \$238,463, compared to a median home value of \$190,791 for the U.S. In five years, median value is projected to change by 2.25% annually to \$266,524.
