Currently, 57.1% of the 99,044 housing units in the area are owner occupied; 19.8%, renter occupied; and 23.1% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 94,802 housing units in the area - 59.6% owner occupied, 17.1% renter occupied, and 23.3% vacant. The annual rate of change in housing units since 2010 is 1.96%. Median home value in the area is \$134,144, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 5.15% annually to \$172,467.
