ORDINANCE NO. 2019-36

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ST. CLOUD, FLORIDA, TO ANNEX INTO THE CITY OF ST. CLOUD APPROXIMATELY 1.67 ACRES IDENTIFIED AS LOT 32, HICKORY TREE ROAD, LOCATED AT THE NORTHWEST CORNER OF HICKORY TREE ROAD AND OLD HICKORY TREE ROAD; IN ACCORDANCE WITH THE VOLUNTARY ANNEXATION PROVISIONS OF CHAPTER 171.044, FLORIDA STATUTES.

WHEREAS, the owners of the properties described below, being Curtis Graulich and Kenneth Burkholder, have petitioned the City Council of the City of St. Cloud, Florida, pursuant to Chapter 171.044, Florida Statutes, requesting annexation into the City of St. Cloud, Florida in a petition signed and dated April 23, 2019; and,

WHEREAS, the City Manager of the City of St. Cloud, Florida, has certified by review of the Certificate of Title dated May 24, 2019, that the owner of the property has signed the Petition for Annexation; and,

WHEREAS, the City Council has received the recommendation of Planning Commission dated July 16, 2019; and,

WHEREAS, the property is reasonably compact and contiguous to the corporate areas of the City of St. Cloud, Florida and annexation will not result in the creation of any enclave; and,

WHEREAS, the City of St. Cloud, Florida, has provided or will provide municipal services to the property, and has found it in the best interest of the City to accept the petition for annexation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Cloud, Florida, as follows:

SECTION 1:

That the following property, as also shown in Exhibit "A", is annexed into the City of St. Cloud, Florida, pursuant to Chapter 171.044, Florida Statutes:

LOT 32, THE SEMINOLE LAND AND TNVESTMENT COMPANY'S (INCORPORATED) SUBDIVISION 0F SECTION 19, TOWNSHIP 26 SOUTH, RANGE 31 EAST, AS PER PLAT THEREOF, RECORDED IN PLAT BOOK 'B' PAGE 25, OF THE PUBLIC RECORDS OF OSCEOLA COUNTY, FLORIDA, LESS ROAD RIGHT OF WAY, PURSUANT TO COUNTY ROAD MAP IN BOOK 1, PAGE 55 FILED AUGUST 26, 1988 PUBLIC RECORDS OF OSCEOLA COUNTY, FLORIDA, AND LESS AND EXCEPT THE FOLLOWING:

A PARCEL OF LAND BEING A PORTION OF LOT 32, THE SEMINOLE LAND AND INVESTMENT COMPANY'S SUBDIVISION OF SECTION 19, TOWNSHIP 26 SOUTH,

RANGE 31 EAST, AS RECORDED IN PLAT BOOK "B" PAGE 25, OF THE PUBLIC RECORDS OF OSCEOLA COUNTY, FLORIDA AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHWEST CORNER OF SAID LOT 32; THENCE RUN S 00°30'10" W ALONG THE WEST LINE OF SAID LOT 32, A DISTANCE OF 249.09 FEET TO THE POINT OF BEGINNING; THENCE RUN S 89°38'39" E, A DISTANCE OF 625.56 FEET TO A POINT ON THE WEST RIGHT OF WAY RIGHT OF WAY LINE OF HICKORY TREE ROAD (STATE ROAD 15); THENCE ALONG SAID WEST RIGHT OF WAY LINE OF THE FOLLOWING TWO (2) COURSES AND DISTANCES; THENCE RUN S 01°46'38" W, A DISTANCE OF 23.71 FEET; THENCE RUN S 46°22'58" W, A DISTANCE OF 27.79 FEET TO THE POINT ON THE NORTH MAINTAINED RIGHT OT WAY LINE OF OLD HICKORY TREE ROAD PER OSCEOLA COUNTY ROAD MAP BOOK 1, PAGE 55; THENCE RUN N 89°38'39" W ALONG SAID NORTH RIGHT OF WAY LINE, A DISTANCE OF 605.08 FEET TO A POINT ON AFORESAID WEST LINE OF LOT 32; THENCE RUN N 00°30'10" E ALONG SAID WEST LINE, A DISTANCE OF 43.00 FEET TO THE POINT OF BEGINNING.

CONTAINING 0.613 ACRES, MORE OR LESS.

REMAINING LOT 32 CONTAINS 3.58 ACRES MORE OR LESS

ALSO LESS AND EXCEPT THE FOLLOWING:

BEGINNING AT THE NORTHWEST CORNER OF LOT 32; THENCE RUN S 00°30'10" W ALONG THE WEST LINE OF SAID LOT 32, A DISTANCE OF 249.09 FEET TO A POINT 45.00 FEET N 00°30'10" E OF THE NORTH RIGHT OF WAY LINE OF OLD HICKORY TREE ROAD; THENCE RUN S 89°38'39" E, PARALLEL TO SAID NORTH RIGHT OF WAY LINE, A DISTANCE OF 312.78 FEET; THENCE RUN N 01°08'19" E, A DISTANCE OF 248.64 FEET TO THE NORTH LINE OF AFORESAID LOT 32, THENCE RUN N 89°33'29" W ALONG SAID NORTH LINE 315.54 FEET TO THE POINT OF BEGINNING.

CONTAINS 1.79 ACRES MORE OR LESS

TRACT B CONTAINS 1.79 ACRES MORE OR LESS.

Including the full width of any and all adjacent rights-of-way.

SECTION 2:

That occupants and owners of the property shall be entitled and subject to all the rights, privileges, immunities, and responsibilities of occupants and owners of property in the City of St. Cloud, Florida, as provided in Chapter 171, Florida Statutes.

SECTION 3:

If any section or portion of a section of this ordinance proves to be invalid, unlawful or unconstitutional, it shall not be held to impair the validity, force or effect of any other section or part of this ordinance.

SECTION 4:

The City Clerk, after consultation with the City Attorney, is authorized to correct scrivener's errors found by filing a corrected copy of this ordinance in the official records of the City.

SECTION 5:

Effective Date. This ordinance has been published and shall take effect as provided by law.


