Said 181.406 acre tract is the residue of a 250 acre tract described in a deed to Q.K. Barber as recorded in Volume 53, Page 283 of the Chambers County Deed Records and Volume 211, Page 343 of the Liberty County Deed Records and is more particularly described by metes and bounds as follows:

BEGINNING at a 1-inch iron pips found at the point of intersection of the west line of State Highway No. 146 as recorded in Volume 213, Page 547 of the Liberty County Deed Records (based on a width of 120-feet) with the south line of said 250 agre tract;

THENCE, South 57'31'13" West, along the south line of said 250 acre tract, same being the north line of an 80 acre tract described in a deed to Wilms Barber Mattingly as recorded in Volume 501, Page 556 of the Liberty County Deed Records, for a distance of 5082.04 feet to a 5/8-inch iron rod found for the southwest corner of the herein described tract, said point being in the east line of a 41.52 acre tract described in a deed to Coastal Industrial Water Authority as recorded in Volume 652, Page 669 of the Liberty County Deed Records;

THENCE, North 07'21'00" West, along the lower east line of said 41.52 acre tract for a distance of 1514.00 feet to a 5/8-inch iron rod found for corner;
