

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR COTTONWOOD ESTATES UNIT I

This Declaration is made this 19th day of June, 1985, by Western States Development, Inc., an Arizona corporation, the Owner of the following described real property located in the County of Maricopa, State of Arizona (hereinafter referred to as the "Property"):

WHEREAS, it is the desire and intention of the Owner to develop the Property for multi-family residential use; and

WHEREAS, the Owner desires to impose upon certain parts of the Property, Covenants, Conditions and Restrictions for the benefit of all the Property and the future owners.
