COMMENCING AT A CONCRETE MONUMENT AT THE NORTHWEST CORNER OF TRACT #4 ACCORDING TO PLAT OF LANDS OF THE UNITED CLAY MINES CORPORATION AS RECORDED IN MAP BOOK 2, AT PAGE 56 OF THE PUBLIC RECORDS OF PUTNAM COUNTY, FLORIDA, AND RUN THENCE S.88°47'E., ALONG THE NORTH LINE OF SAID TRACT #4, A DISTANCE OF 699.25 FEET TO THE SOUTHEASTERLY RIGHT-OF-WAY OF STATE ROAD #S20A, AND THE POINT OF BEGINNING OF THIS DESCRIPTION. FROM POINT OF BEGINNING (1) RUN THENCE S.42°50' E., ALONG SAID RIGHT-OF-WAY, A DISTANCE OF 294.24 FEET TO THE P.C. OF A CURVE, CONCAVE TO THE NORTHEAST, HAVING A RADIUS OF 1472.69 FEET AND A CENTRAL ANGLE OF 44°24'30", (2) THENCE ALONG SAID CURVE, AN ARC DISTANCE OF 99.81 FEET TO A CONCRETE MONUMENT; (3) THENCE RUN S.47°10' W., A DISTANCE OF 215.38 FEET TO A CONCRETE MONUMENT; (4) THENCE RUN N.42°50'W., A DISTANCE OF 318.10 FEET TO A CONCRETE MONUMENT SET ON THE WATER'S EDGE OF A SMALL LAKE; (5) THENCE NORTHERLY, MEANDERING SAID WATERS A DISTANCE OF 240.00, MORE OR LESS, TO THE POINT OF BEGINNING AND TO CLOSE.
